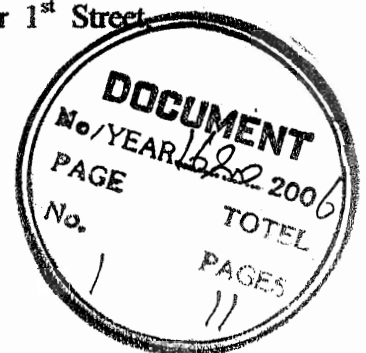

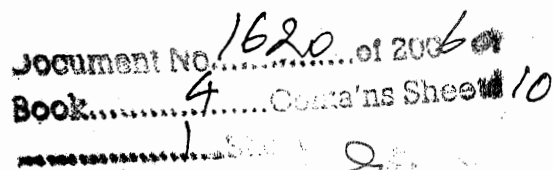

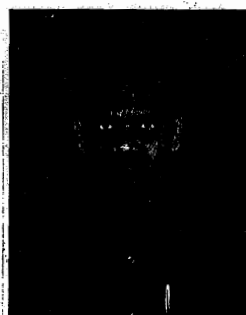

WHEREAS the author is desirous of settling on trust a sum of **Rs.1000/- (Rupees One Thousand Only)** upon the Trustees to carry on the objectives specified below.

AND WHEREAS the author has endorsed in favour of and delivered to the Trustees a sum of Rs. 1000/- (Rupees one thousand only) to hold the same in Trust for the said author subject to the powers provisions and scheme hereinafter declared and expressed.

NOW THIS DEED OF TRUST WITNESSES AS FOLLOWS :

1. The name of the trust shall be “**JEGAMATHI EDUCATIONAL TRUST**”

2. The registered office of the trust shall be situated at 7 & 7A, Thai Moogambigai Nagar, Maruthupandiar 1st Street, Karupayurani Post, Madurai – 625 020 and it may be shifted to any other place from time to time at the discretion of the Trustees.

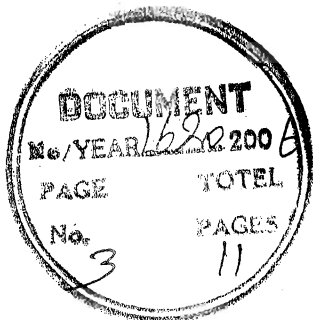
3. The Principal Objects of the Trust are :

- (a) To establish, maintain and run schools and colleges for the benefit of all.
- (b) To establish, maintain and run para-medical teaching institutions that will impart knowledge in physiotherapy , pharmacology, lab-technology, nursing and other related para-medical fields.
- (c) To establish, maintain and run engineering colleges, ITI s, Arts and Science colleges.

- (d) To establish, maintain and run residential schools for improving the overall personality of Children.
- (e) To run training centers for nurses and teachers.
- (f) To run computer training institutes.
- (g) To establish, maintain and run hospitals.
- (h) To establish, maintain and run ladies hostels for students and working women.
- (i) To affiliate all such above institutions with the necessary universities / councils.
- (j) To provide the above education to poor students at a reasonable cost.
- (k) To affiliate all the above institutions with any reputed hospital for providing hands on training.
- (l) To provide medical relief to the poor.
- (m) To help all people during times of natural calamities.
- (n) To establish maintain and run orphanages, old age homes and any other institution that provides shelter to physically and mentally handicapped.
- (o) To start and run reading rooms, study centres, libraries for the diffusion of useful knowledge.
- (q) To provide scholarship to needy students for pursuing their studies at school.college or any other institution.
- (r)To run tuition centres for needy students.
- (s)To run adult literacy classes for the poor.

- (t) To provide help in the form of finance, medicine, hospitalisation or any other help to victims of Aids and Cancer.
- (u) To run community development programmes.
- (v) To organize self help groups
- (w) To help poor people to start small businesses.
- (x) To help in environmental protection by organizing seminars and awareness programmes.
- (y) To help preserve Indian culture by encouraging Indian dance forms, music, theater and art.

All the above objects will be made available to every body irrespective of the caste, colour, sex and creed.

4. THE ANCILLARY OBJECTS OF THE TRUSTS ARE :

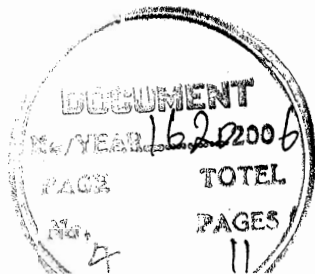
(a) To acquire, purchase, hire, exchange, sell or lease any movable or immovable property to further the objectives of the Trust. However no immovable property of the trust shall be alienated without prior approval of Commissioner of Income Tax

(b) To invest the monies of the Trust not immediately required in such investments as may be permitted by the Section 11 (5) read with Section 13 (1) (d), to be decided by the Trustees.

(c) To draw, make, accept, endorse, and negotiate cheques, promissory notes, bills of exchange, hundies and other negotiable instruments in pursuance of the objects of the Trust.

(d) To borrow or raise funds either by loan or otherwise against the security of any immovable property of the trust, to further the objects of the trust.

(e) To pay out of the funds of the Trust all expenses, incidental to the formation and management of the Trust.

(f) To subscribe or donate for needy, charitable, benevolent and such other objects involving public interest.

(g) To raise donations, contributions or grants either from India or abroad from any persons, company, Trust or Government and

(h) To do generally such other acts, matters or things as may be necessary incidental or ancillary to all or any of the objects mentioned above.

(i) To receive, hold and disperse funds to promote the objects of the Trust.

(j) To register the trust under the Foreign Contribution Regulation Act.

(k) All the activities of the trust shall be carried out in India only.

(l) None of the activities of the trust shall result in profit.

(m) No part of the Income of the trust shall be distributed among the trustees or persons mentioned in section 13 (1) (c) of the Income Tax Act 1961 by way of dividend or profit.

(n) All the incomes of the Trust shall be utilised only towards the object of the Trust.

(o) No part of the Income of the Trust shall be used for any religious purpose or given to any religious institution.

5. Constitution Of the Board Of Trustees :

(a) The trust shall be managed by a board of trustees which shall consist of a minimum of 2 trustees and a maximum of 5 trustees.

At present the board of trustees shall consist of the following persons

- 1) Mr. C. DEENATHAYALAPANDIAN
- 2) Mrs.D.ANITA
- 3) Mr. M.A. CHINNAMARUTHU

The above trustees shall hold office for life

(a) Mr.C.DEENATHAYALAPANDIAN shall be the Managing Trustee and he shall be in over-all control of the day to day affairs of the Trust.

(b) The board may co-opt more trustees subject, to the maximum number of trustees. However no one can be co-opted unless their co-option is consented to by a all the trustees in writing.

6. Removal of Trustees:

(a) Any trustee may be removed by the Board of Trustees for breach of trust or mis-conduct.

(b) Any trustee desirous of retiring from the trusteeship shall be entitled to do so after giving one clear calendar month's notice in writing to the remaining trustees.

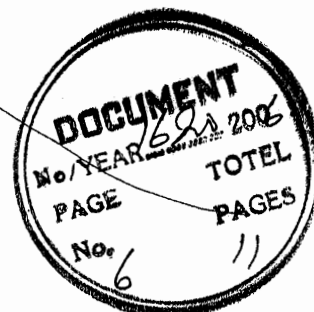
(c) In case of any vacancy in the Board of Trustees arising on account of death, retirement, resignation or otherwise of any trustees, the surviving or remaining trustee or trustees as the case may be shall have full powers to constitute and represent the Board of Trustees for the time being.

(d) The trustees shall, in the case of vacancy have the power to co-opt a Trustee or trustees as the case may be to fill up the vacancy or vacancies as the case may be within a period of thirty days from the date on which the vacancy arises by way of nomination and such trustees/trustee shall hold office for a period of three years after which they may be eligible for re-appointment subject to the consent of the majority of the trustees in writing.

(e) In the event of any vacancy arising in the office of the Managing Trustee by resignation, death or otherwise, the remaining trustees shall at first co-opt a trustee to fill up the vacancy in the Board within thirty days from the date on which the vacancy arise shall elect Mrs.D.Anita as the Managing Trustee.

7. Power of the Board of Trustees :

(a) The board of trustees shall have powers of absolute management of all affairs, activities, and business of the trust. The Managing Trustee shall duly carry out all the decisions made by the Board of Trustees, without limiting or in any way restricting the generality of their powers, the Board of Trustees shall exercise the following powers; namely: -

(b) The Trustees shall pay, expend, apply or utilize the trust fund and all the additions and accretion thereto from time to time or any such part thereof as they shall in the discretion decide for all or any one or more or the objects aforesaid exclusively and not for purposes of profit, No part of the income or corpus of the fund shall utilized for any object or purpose other than those of the Trust. All the objects of the trust shall be made available to every body irrespective of caste, creed, religion, sex etc.,

(c) It shall be lawful for the Board of Trustees to frame rules and regulations for the conduct and management of the Trust.

(d) The Board of Trustees shall determine, from time to time the amount it shall spend on the different aspects of the activities of the Trust subject to payment of tax if any.

(e) The Board of Trustees shall have power to invest the Corpus for the income from the Trust Fund at their discretion in such investments may be permitted under the Income- Tax law, in force, from time to time.

(f) The Board of Trustees shall open an account or accounts with any scheduled bank or banks and all such bank accounts shall be operated by the Managing Trustee singly.

(g) To institute, conduct, defend, intervene in or compromise legal proceedings by or against the Trust.

(h) To appoint committees or sub/committees for looking after the affairs, activities project and business of the Trust.

8. Meetings of the Board of Trustees :

(i) The trustees shall meet as many times as may be considered expedient.

(ii) However, before the expiry of six months from the end of every financial year the trustees shall meet to adopt the statement of accounts for the financial year shall appoint a Chartered Accountant to Audit the accounts of the Trust.

(iii) The meetings shall be convened by the Managing Trustee after giving due notice in writing, to all the trustees, of 7 clear days.

(iv) The Managing Trustee shall maintain minutes of all meetings.

(v) If a shorter notice is given the Board Of Trustees may unanimously ratify the shorter notice.

(vi) The Board shall transact only business that may be specified in the agendas or any other matter that may be brought up with the permission of the chair.

(vii) The Managing Trustees shall preside over all the meetings of the board and in the event of equal votes, he shall have a casting vote.

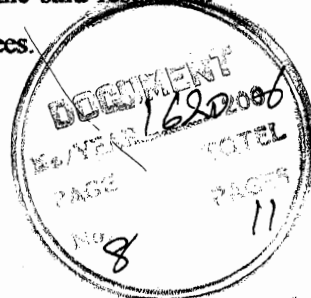
(viii) Two trustees present shall constitute the quorum for the meeting of the Board of Trustees. If after two adjournments the quorum is not present the members present shall constitute the quorum.

(ix) Unless otherwise provided herein, all decisions shall be carried by a simple majority and in the event of equality of votes the issue shall be decided by the casting vote of Managing Trustee.

(x) Any resolution in writing circulated to all the Trustees and accepted and signed by a simple majority of the Trustees in token of their said acceptance shall be valid and binding on the Board of Trustees as though the said resolution had been passed at a duly convened meeting of the Board of Trustees.

(xi) The Board of Trustees may invite any other person or persons interested in the work of the Trust to attend the meetings of the Board of Trustees, but they shall not be entitled to vote there at on any matter or resolution.

9. Property of the Trust :

(i) All the properties of the Trust as and when acquired whether movable or immovable shall at all times stand vested in the Trustees.

(ii) All funds of the Trust, as and when acquired, shall be invested in such manner as may be approved by Section 13 (1) (d) read with section 11 (5) of the Income Tax Act 1961.

10. Financial Year :

The Financial year of the trust shall be from the 1 April to the 31st March of the following year and regular accounts shall be maintained in the normal course, accordingly.

11. Accounts and Audit :

(i) The accounts of the trust shall be annually audited by a Chartered Accountant appointed by the Board of Trustees and the audited statements of account and the Auditor's report thereon shall be placed before the Board of Trustees for its approval and adoption within six months from the close of the financial year.

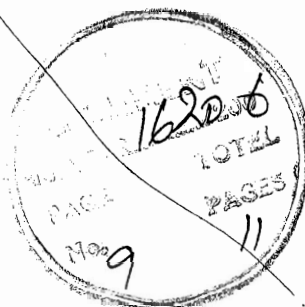
(ii) The Trust shall apply for registration with the Commissioner of Income Tax as a Non-profit organization.

12. Amendments :

This trust shall be irrevocable. Though this Trust shall be irrevocable, the Board of Trustees may subject to the prior approval of the Commissioner of Income- Tax amend any of the clauses contained herein in relation to the Management of the Trust at a duly convened meeting of the Board of Trustees by a resolution passed unanimously of which resolution, atleast two week's notices shall have been given to all the Trustees.

13. Winding up

(i) If the Trustees decide that no useful purpose will be achieved by the continuation of the Trust, it shall be open to the Trustees to dissolve and wind up the Trust.

(ii) In the event of such dissolution or winding up of the Trust, the assets and properties of the Trust or any part thereof shall not be appropriated by or distributed among the Trustee or the staff of the Trust or their relatives.

(iii) In such event of dissolution of winding up of the Trust, the assets and properties or any valuable part thereof shall be disbursed, transferred and assigned to any other trust having similar objects and Registered under section 12AA and 80G of Income Tax Act 1961.

14. General :

(i) The Trustees shall at all times stand indemnified in respect of any ~~acts of commission or omission by them in respect of matters relating to the Trust.~~

(ii) The Trust shall be irrevocable.

15. At present this trust has no immovable or movable property other than the above nucleus fund Rs.1000/-.
